

City Applies for EDCC Re-Certification

ime sure flies. We have been notified that Chadron's 5 year certification as an Economic Development Certified Community (EDCC) will expire this month. This program, offered by the NE Department of Economic Development is a preparatory process that once met, assures those who come calling that we are ready for development in our community. The requirements include having land or buildings available for locating here. It also assures that we have incentives, assistance, expertise and experience in making deals work, welcoming new people and businesses and have systems in place to assist existing business-

Annual Meeting Set For Jan. 19

The Bylaws of the Northwest Nebraska
Development Corporation (NNDC) state that an annual membership meeting will be held in January, and that an election of officers will take place at that time for new members of the Board of Directors. We have set the date for Friday January 19, 2018 at noon. We will, as in the past, hold the meeting at the Country Kitchen banquet facility. A buffet lunch will be followed by the election of board members and comments from the outgoing President of the Board of Directors and Executive Director. In addition to comments, you will receive an annual report of the most recent 12 months activities of the organization. This is a snapshot of what we have been doing the past 12 months. Be watching your email for your invitation.

es stay in business and expand. The re-certification application is a great tool to help put down on paper the success the community has experienced in the past five years, as well as point to areas that need improvement. The application has been submitted and we are awaiting word from DED with questions, clarifications and changes we need to make in order to continue to enjoy 'Certified' status.

Some of the numbers collected were surprising – in a good way. For example, we need to track the number of jobs created, retained and lost since we were first certified in 2012. They are split into primary and non-primary categories. In total we created 120 new jobs, gained 40 from expansions and were successful in retaining (or saving) another 20. That's a grand total of 180 paychecks that would not be here if not for our efforts. There have been 17 new businesses open, and 17 expansions. On the downside, we had 6 businesses close in that timeframe, eliminating 30 jobs. While the process is a fluid one, and what some folks consider regular maintenance, others might consider expansion, we think this is a realistic snapshot of the past 5 years' activity.

We also report on investments in our community that impact our economic growth and potential. Capital investment in new jobs was over \$12 million. Expansions added over \$3 million. Also included in our application was the recognition of government buildings and infrastructure investments which totaled almost \$59 million. This included the storm water runoff system, highway 20 rebuild, Chadron Aquatic Center, CSC buildings, NDOT headquarters and runway rebuilding. All together we have invest nearly \$75 million actual dollars in our community. That's about \$12,500 for every resident of the community!! Pretty impressive. Chadron Housing Partnership Hosts Housing Study Session

NNDC and the City of Chadron are hosting a very important session on Thursday, Dec.r 14, 2017 at 11 a.m. at the Country Kitchen. We will hear from Tim Keelan, one of the co-authors of the recently finished Chadron Housing Study. The study lays out the research and numbers which indicate we need somewhere north of 250 additional housing units to meet the current demand. That seems like a huge number, and frankly causes some wide-eyed looks and frustrated expressions about how we address that. So, how do you eat an elephant? One bite at a time. The meeting is designed to hear about the breakdown (houses/apartments/owner-occupied/rental/senior/student/affordable/lowincome) and most importantly to discuss what are the current barriers and possible solutions to creating a plan to build and/or provide more

Invitations have been sent to those who we are aware are interested in helping with this effort. If you would like to attend, and did not receive an invitation, please don't hesitate to call the office and let Deb know you will attend. The meeting is designed to last an hour, and those who can are encouraged to stay for a nohost lunch for further discussion. We know housing is important to economic growth, for both employees and their families. Please help us determine the most efficient path to addressing this important issue.


