In an agreement with the city, they helped extend utilities, paved (or built) the road to their front door and in the process have opened the adjacent land to annexation and future building to the west. There is also greater ability for Fuller to develop the land to the south

of their offices.

Heartland Expressway Moves Toward Next Building Phase

The Nebraska Department of Transportation (NDOT) provided an update on their current and future plans for the Heartland Expressway at the Aug. 15 Annual meeting of the Association held in Gering, NDOT District Director Doug Hoevet provided comments regarding the next phase which will be the addition of 2 more lanes of traffic along US Highway 26 and L62A from Minatare, NE to the US Highway 385 junction 18 miles to the east. When completed, this will make the existing 4lane divided highway from I-80 south of Kimball to Alliance, NE a 110 mile stretch. The NDOT is currently planning the exact route, determining where additional right of way will need to be purchased and finishing any environmental investigation needed. Senator Deb Fischer has submitted a Congressionally Designated Request for funding in the amount of \$12.865 million for this phase.

Why is this so important to the northern half of the Heartland Expressway? Because it will funnel traffic north from Alliance, which will increase the need for additional work to be done on the segment from Alliance to the SD border. As has been stated many times, the 4-lane divided highway north and south through Western Nebraska is a critical trade corridor. Connecting further to the 4-lane expressways on either side, as well as Interstate highways is the goal to provide the best, safest route from Mexico to Canada. Commerce follows the most efficient transportation routes, and that brings revenue, support business, visitors and economic development. Building roads is a long-term process and we are keeping NDOT accountable to their promise of building the Heartland Expressway through the entire state.

The Ports to Plains Alliance (umbrella organization) CEO Lauren Garduno spoke and provided stats of why this route (all the way from Mexico, through Texas, Colorado, the Dakotas and into Canada) is dependent on each state to provide the most efficient flow of traffic, in order to attract the business of moving the food, fuel and fiber that serves the US. Nebraska is right in the middle of the route and stands to gain as much business from this effort as any of the 'heartland' states.
